Biographical Sketch

Clifford Brown, resident of Thunder Bay had a long-time interest in the Port Arthur, Duluth and Western Railway (P.A.D.& W.). He collected this material with the aim of producing a book on the Port Arthur, Duluth and Western Railway. Mr. Brown died in 1991 without the book having been completed.

Scope and Content

Mostly newspaper photocopies from the late nineteenth century, including an index to the clippings and research files on the subject of the railway. Also includes files on the history of the areas traversed by the railway line. Arranged into three series:

Series A 1/1/1-55 - Newspaper clipping files - 47cm. - 1875-1921 (photocopies).

55 file folders containing entries from the *Thunder Bay Sentinel*, the *Fort William Herald*, the *Fort William Weekly Journal and Thunder Bay Mining News*, the *Weekly Herald*, the *Daily Times- Journal*, the *Port Arthur Daily News* and the *News-Chronicle* covering the period from 1875 to 1921. Arranged chronologically. Annotated. Many copies badly faded. Box 1 -1875-89 (22 files); Box 2 -1889-96 (19 files); Box 3 -1896-1904 (9 files); Box 4 -1905-21 (5 files).

Series A 1/2/1 - Index, 27cm. - 1883-1899

Card index to newspaper files and other files of the collection. Files have been rearranged since index was made so locations listed on cards are inaccurate.

Series A 1/3/1-16 - Research files - 20cm. - 1879-1899, 1931, 1978
