### Thunder Bay Memorial Society Fonds

Originals and photocopies, 70.5 cm of textual records, 1963-2007.

**Scope and Content:** The fonds of the Thunder Bay Memorial Society consists of six series which span from 1963 to 2007. It includes minutes of various meetings, legal documents, trial transcripts, surveys, research, reports, and a wide variety of miscellaneous documents, largely consisting of correspondence and newspaper clippings. All of this information can be found in 47 file folders, three binders, one ledger, and one spiral bound book.

**Series E 84/111-9:** Minutes, 42.5 cm, 1963-2003 (originals and photocopies).

One binder, one ledger, 34 folders. Organized chronologically. Related correspondence, financial legal documents, forms, newsletters, speeches, pamphlets, membership lists, media references, petitions, book lists in some folders

**Organizational Sketch:** The Memorial Society of Thunder Bay was established in 1971, after the Lakehead Unitarian Fellowship was unable to establish a mortuary society in 1963. The intent of the memorial society is to provide members of the society with a simple, yet dignified burial service that does not require what is often seen as extravagance from the funeral industry. The society found resistance constantly as they grew, largely from the four funeral homes in Thunder Bay. In order to circumvent the legalities associated with removal and burial/cremation, Co-Op Memorial and Removal Services was established in 1978 by seeking incorporation, though the official charter was not received until 1979. After much contention over the removal of a deceased member, who did not want to be embalmed, from a funeral home, Eric Gowen (president) and the Co-Op were given summons to appear in court in September, 1980. The ensuing trial changed the face of funeral legislation and has had a resounding impact. The Co-Op Memorial and Removal services became the Northwest Funeral Alternative in 1997. The Memorial Society of Thunder Bay continues to work in partnership with Northwest Funeral Alternative to provide dignified burials and cremations at reasonable prices.
